

Official Rules (“Official Rules”)

The Chevrolet Winter 2020 Jingle Ball Sweepstakes

NO PURCHASE NECESSARY

PROMOTION DESCRIPTION: The Chevrolet Winter 2020 Jingle Ball Sweepstakes (the “**Sweepstakes**”) takes place beginning November 2, 2020 at 12:00:01 a.m. Pacific Standard Time (“**PST**”) and ending November 30th, 2020 at 11:59:59 p.m. PST (the “**Promotion Period**”). Entry in the Sweepstakes does not constitute entry into any other promotion, contest or sweepstakes. By participating in the Sweepstakes, each entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of Chevrolet Motor Division, General Motors LLC located 30930 Russell Ranch Road Suite 130 / Westlake Village, CA 91362 (“**Sponsor**”), which shall be final and binding in all respects.

ELIGIBILITY: Only legal United States residents who are eighteen (18) years of age, possess a valid California driver’s license and reside in the Southern California counties of: Santa Barbara, Ventura, Los Angeles, San Bernardino, Orange, Riverside, San Diego, and Imperial, are eligible to enter. Employees, officers and directors of Sponsor, iHeartMedia + Entertainment, Inc. (“**Administrator**”), and each of their respective parents, subsidiaries, affiliates, distributors, retailers, sales representatives, advertising and promotion agencies (collectively, the “**Promotion Entities**”) and the immediate family members, and/or those living in the same household of each, are ineligible to enter the Sweepstakes or win a prize. Sweepstakes is void where prohibited by law.

HOW TO ENTER: During the Promotion Period, visit the website www.kiisfm.com/chevy (the “**Website**”), locate the link to the Sweepstakes registration page, complete the entry form with the information requested, complete a brief survey, and follow the on-screen instructions to receive one (1) entry into the Sweepstakes. All requested information on the entry form at the Website must be completed to enter and to be eligible to win. Incomplete entries will be disqualified. Proof of entering information at the Website is not considered proof of delivery to or receipt by Sponsor of such entry. Except as contemplated in these Official Rules, personal information collected in connection with this Sweepstakes will be used in accordance with the privacy policy found on the Website.

NOTE: Internet entry must be made by the entrant, only at the Website. Entries made by any other individual or any entity, and/or originating at any other web site or e-mail address, including but not limited to commercial sweepstakes subscription notification and/or entering service sites, will be declared invalid and disqualified for this Sweepstakes. The use of any device to automate the entry process is prohibited.

The Website’s database clock will be the official timekeeper for online entries in this Sweepstakes. In the event a dispute regarding the identity of the individual who actually submitted an entry cannot be resolved to Sponsor’s satisfaction, the affected entry will be deemed ineligible. The Promotion Entities shall not be responsible for incorrect or inaccurate entry information whether caused by Internet users or by any of the equipment or programming associated with or utilized in the Sweepstakes or by any technical or human error which may occur in the processing of the entries in the Sweepstakes. The Promotion Entities assume no responsibility or liability for any error, omission, interruption, deletion, theft or destruction, or unauthorized access to, or alteration of entries.

Limit one (1) entry per person and/or per e-mail address.

FINALIST SELECTION AND NOTIFICATION: At the end of the Promotion Period, representatives

of Administrator will randomly select five (5) potential finalists (each, a “**Finalist**”) from all eligible entries received during the Promotion Period. The potential Finalists will be notified by telephone and/or email, using contact information provided or collected at the time of entry. Sponsor shall have no liability for any Finalist notification that is lost, intercepted or not received by a potential Finalist for any reason. If, despite reasonable efforts, a potential Finalist does not respond within forty-eight (48) hours of the first notification attempt, or if the notification is returned as unclaimed or undeliverable to such potential Finalist, such potential Finalist will forfeit his or her status as a Finalist and an alternate Finalist may be selected. Sponsor, in its sole discretion, will attempt to contact up to three (3) potential Finalists for any Finalist slot in accordance with the above procedure, after which the Finalist slot in question may go un-awarded if it remains unclaimed. If any potential Finalist is found to be ineligible, or if he or she has not complied with these Official Rules or declines his/her status as a Finalist for any reason, such potential Finalist will be disqualified and an alternate Finalist may be selected, time permitting. **The odds of being selected as a Finalist depend on the number of eligible entries received.**

VIRTUAL FINALIST EVENT: The up to five (5) confirmed Finalists will be notified of the Grand Prize Drawing and given a unique number (each, a “**Finalist Number**”) in order to participate in the Grand Prize Drawing. During the Grand Prize Drawing, one (1) Grand Prize winner will be randomly selected on or about December 7, 2020 at 6:30 p.m. PST. The potential Grand Prize Winner will be announced live on KIIS-FM on or about December 7, 2020 at 7:00 p.m. PST and will also be notified via telephone and must respond to one (1) of two (2) notification attempts made immediately following the Grand Prize Drawing. In the event any Finalist is unable to respond immediately for any reason, such Finalist will forfeit his/her right to receive any prize which he/she may have otherwise been eligible to receive and an alternate Finalist Number may be selected. Sponsor reserves the right to proceed with the Finalist Event with fewer than five (5) Finalists. The maximum odds of winning the Grand Prize are 1:5.

PRIZE:

One (1) Grand Prize is available. The Grand Prize consists of a 2021 Chevrolet Trailblazer FWD 4dr LT, (the “**Vehicle**”) with an MSRP of \$24,595.

The MSRP of the Vehicle is subject to price fluctuations in the consumer marketplace based on, among other things, any gap in time between the date the MSRP is estimated for purposes of these Official Rules and the date the prize is awarded or redeemed. Vehicle will be delivered with standard equipment for make and model; all upgrades and options, are at the sole cost of winner. Winner will not have choice of color. Title, taxes, registration, license, and similar fees, and insurance costs are the sole responsibility of the winner. Winner must possess a valid U.S. driver’s license. Winner will be required to show proof of currently valid driver’s license and insurance prior to taking delivery of the vehicle. Prize will be delivered to **iHeartMedia at 3400 W Olive Ave. Burbank, CA 91505**, and if winner does not pick up prize within thirty (30) days of delivery notice, prize will be forfeited and may be awarded to an alternate winner. Vehicle will be delivered solely with the express limited warranties set forth in the vehicle’s Owner’s Guide.

GENERAL PRIZE CONDITIONS: No cash alternative or prize substitutions will be allowed, except Sponsor reserves the right to substitute prize(s) of comparable value if a prize listed is unavailable for any reason. Prize winner shall be solely responsible for all federal, state and/or local taxes, and the reporting consequences thereof, and for any other fees or costs associated with the applicable prize. All potential Finalists must sign and return an Affidavit of Eligibility, a Liability Release, and (where imposing such condition is legal) a Publicity Release (collectively, “**Prize Claim Documents**”). If any Finalist fails or refuses to sign and return all Prize Claim Documents prior to participating in the Finalist Event, such Finalist may be disqualified and an alternate Finalist may be selected. Any potential Grand Prize winner may have

to sign and have notarized additional applicable Prize Claim Documents prior to receiving a prize.

Sponsor makes no warranties, and hereby disclaims any and all warranties, express or implied, concerning any prize furnished by third parties in connection with the Sweepstakes. WITHOUT LIMITING THE GENERALITY OF THE FOREGOING, SUCH PRIZES ARE PROVIDED "AS IS" WITHOUT WARRANTY OF ANY KIND, EITHER EXPRESS OR IMPLIED, AND SPONSOR HEREBY DISCLAIMS ALL SUCH WARRANTIES, INCLUDING BUT NOT LIMITED TO, THE IMPLIED WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE AND/OR NON-INFRINGEMENT.

Sponsor reserves the right in its sole discretion to disqualify any individual who is found to be tampering with the entry process or the operation of the Sweepstakes or the Website, to be acting in violation of these Official Rules, or to be acting in an unsportsmanlike or disruptive manner, or with the intent to disrupt or undermine the legitimate operation of the Sweepstakes, or to annoy, abuse, threaten or harass any other person, and Sponsor reserves the right to seek damages and other remedies from any such person to the fullest extent permitted by law. No mechanically reproduced, illegible, incomplete, forged, software-generated or other automated multiple entries will be accepted. Sponsor reserves the right to modify, extend, suspend, or terminate the Sweepstakes, including any entry mechanism, if it determines, in its sole discretion, that the Sweepstakes is technically impaired or corrupted or that fraud or technical problems, failures or malfunctions or other causes beyond Sponsor's control have destroyed or severely undermined or to any degree impaired the integrity, administration, security, proper play, safety, and/or feasibility of the Sweepstakes as contemplated herein. In the event Sponsor is prevented from awarding prizes or continuing with the Sweepstakes as contemplated herein by any event beyond its control, Sponsor shall have the right to modify, suspend, or terminate the Sweepstakes. If the Sweepstakes is terminated before the designated end date, Sponsor will (if possible) select Finalists in a random drawing from all eligible, non-suspect entries received as of the date of the event giving rise to the termination. Inclusion in such drawing shall be each entrant's sole and exclusive remedy under such circumstances. shall be construed in accordance with their terms as if the invalid or illegal provision were not contained herein.
